RENEW REQUEST FOR PROPOSALS NO. 116-AA10 - EDUCATIONAL SUBJECT: CONSULTATION SERVICES TO PROVIDE ASSISTANCE ADDRESSING CONTENT AND INSTRUCTIONAL STRATEGIES IN LOW-PERFORMING SCHOOLS

The purpose of this Request For Proposals, opened on March 6, 2001, was to establish a contract, to provide assistance in addressing content and instructional strategies to improve student achievement in low-performing schools, for the Office of Curriculum Support Services. The terms of agreement, as contained in the subject proposal, awarded by the Board on March 14, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this proposal, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of November 2001, indicated an increase of 1.9%.
