SUBJECT: RENEW BID NO. 136-AA11 - MOVING OF FURNITURE AND EQUIPMENT

The purpose of this bid, opened on April 12, 2001, was to establish a contract, with pre-qualified vendors, at firm unit prices, for the relocation, assembly and/or installation of new and existing office and school furniture, and specified fixtures and equipment, for Capital Improvement Projects of Facilities Planning and Construction and various schools and departments. The terms of agreement, as contained in the subject bid, awarded by the Board on May 16, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of November 2001, indicated an increase of 1.9%.
