SUBJECT: REQUEST FOR SCHOOL BOARD APPROVAL OF THE RENEWAL OF THE AMENDED CHARTER SCHOOL CONTRACTUAL AGREEMENT WITH WORK AMERICA, INC.

As per Section 228.056(10)16(b), Florida Statutes, a charter school contractual agreement may be renewed every five school years. Rosa Parks Community School was founded by Work America, Inc. a non-profit organization organized under the laws of the State of Florida. The charter school commenced operations during the 1999-2000 school year under a contractual agreement for a three-year period. The charter school has requested that: the contractual agreement be renewed for a five-year period commencing with the 2002-2003 school year; the grade configuration be changed from grades four through six to kindergarten through eight; the enrollment capacity be increased to 600 students by year five of the contract; the school relocate to a facility at 315 West Palm Drive, Florida City, Florida; and the name of the school be changed to Rosa Parks Charter School/Florida City.

The Charter School Contract Review Committee met on April 15, 2002, and by a majority vote made a recommendation for approval of the renewal of the amended charter school contractual agreement.

Rosa Parks Charter School/Florida City will be open to any student in grades kindergarten through eight residing in Miami-Dade County. District schools in close proximity to the charter school at its proposed location include:

- 3. increase student enrollment to 600 by year five of the contract;
- 4. relocate to a facility at 315 West Palm Drive, Florida City, Florida; and
- change the school name to Rosa Parks Charter School/Florida City.
