SUBJECT: AUTHORITY TO AMEND THE CAPITAL CONSTRUCTION BUDGET

The capital construction budget is being amended to provide additional funding for completion of on-going projects, to closeout accounts and to transfer unused amounts to central reserves to provide contingencies for future use. Due to extensive termite damage discovered in a project in progress, funding was included for North Beach Elementary window replacement.

On page 1, the total of \$2,567,264 is comprised primarily of excess project allocations that can be transferred to central reserves and contingency accounts. On pages 2 and 3, the total of \$4,756,796 represents projects that require additional funds. The net result is a decrease of \$2,189,532 to the central reserves and contingency accounts. The following adjustments are necessary to affect these changes.
