**SUBJECT: RENEW BALANCE BID NO. 078-AA03 - VENDING MACHINE
SERVICE - ACCESS FEE BASED**

The purpose of this bid, opened on January 11, 2001, was to establish a contract, at a firm annual access fee per senior high school location, paid to Miami-Dade County Public Schools, to provide vending machine service at thirty-five (35) senior high and vocational schools. The terms of agreement, as contained in the subject bid, awarded by the Board on February 14, 2001, and partially renewed on March 13, 2002, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file, with the exception of AAAA Vending Company, Inc., of Miami, Florida, for Item 90 - Snack merchandiser, Miami Springs Senior High and Item 91 - Food merchandiser, Miami Springs Senior High, B & C Vending, Inc., of Miami, Florida, for Item 10 - Snack merchandiser, Coral Gables Senior High and Item 11 - Food merchandiser, Coral Gables Senior High, G & P Vending Service, Inc., of Miami, Florida, for Item 102 - Snack merchandiser, North Miami Beach Senior High and Item 103 - Food Merchandiser, North Miami Beach Senior High, The MTJ Group, Inc., d.b.a. One Stop Vending, of Davie, Florida, for Item 50 - Snack merchandiser, Miami Carol City Senior High, and Item 51 - Food merchandiser, Miami Carol City Senior High, and Pan-Am Vend-Tronics Corporation, of Hialeah, Florida, for Item 130 - Snack merchandiser, Robert Morgan Vocational High and Item 131 - Food merchandiser, Robert Morgan Vocational High, who elected not to renew. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current firm annual access fee, to benefit from a fixed fee, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), for food and beverages, as of February 2002, indicated an increase of 2.7%.

The previous award for Item 15 - Food merchandiser, Coral Reef Senior High, incorrectly listed a price of \$2,000 per year, instead of \$500 per year, and Item 82 - Snack merchandiser, Miami Palmetto Senior High, incorrectly listed a price of \$17,157 per year, instead of \$17,154 per year, for Great American Vending, Inc., of Miramar, Florida. The recommendation reflects a correction on the renewal award for these items.

Item 61 - Food merchandiser, Miami Edison Senior High, awarded to Florida Coca-Cola Bottling Company, of Miami, Florida, renewed by the Board on March 13, 2002, inadvertently listed an award for food merchandiser. The recommendation reflects a correction on the renewal balance award to reflect an award for Item 61 - Beverage vending machine, Miami Edison Senior High.

The subject renewal balance recommended for award herein will generate revenues of approximately \$472,443.

Inasmuch as the effective date of this bid is May 15, 2002, through March 31, 2003, quarterly payments are to be made by awardees, retroactive to April 1, 2002, through March 31, 2003.
