The purpose of this Request For Proposals, opened on April 18, 2000, was to establish a contract, at a firm price, to engage a cost-recovery agent, to implement procedures for obtaining reimbursement for services provided to Medicaid eligible students, who are also eligible under the Individuals with Disabilities Act (IDEA), for the Office of Exceptional Student Education and Student Services. The terms of agreement, as contained in the subject proposal, awarded by the Board on June 21, 2000, and renewed on May 16, 2001, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its first renewal period. The awardee has agreed to renew for the second one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this proposal, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of February 2002, indicated an increase of 1.1%.
