**SUBJECT: AUTHORITY TO AMEND THE CAPITAL CONSTRUCTION BUDGET**

The capital construction budget is being amended to provide additional funding for completion of on-going projects, to closeout accounts, to allocate funding for property taxes and special assessments and to transfer unused amounts to central reserves to provide contingencies for future use.

On pages 1 and 2, the total of \$986,450 is comprised primarily of excess project allocations that can be transferred. On pages 3 through 5, the total of \$857,939 represents projects that require additional funds and provision for spreading a portion of the real estate taxes (\$184,756) and special assessments (\$357,941) previously approved by the Board (Item D-6, 2/13/2002) to the appropriate account structures. The net result is an increase of \$128,511 to the central reserves and to contingencies. The following adjustments are necessary to effect these changes.
