**SUBJECT: EXTEND CONTRACT NO. 190-ZZ05 – CLASSROOM SUPPLIES,
CATALOG DISCOUNT**

COMMITTEE: FINANCIAL AFFAIRS

The purpose of the bid, opened on June 1, 2000, was to establish a contract, to purchase, at firm discounts, quantities, as may be required, of classroom supplies, for various schools. The terms of agreement, as contained in the contract, awarded by the Board on August 23, 2000, and extended on August 22, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardees have agreed to extend for the second one (1) year extension period, by letter, on file, with the exception of Albanesi Educational Center, of Carrollton, Texas, American Guidance Service, Inc. (AGS), of Circle Pines, Minnesota, BMI Educational Services, Inc., of Dayton, New Jersey, Community Products, LLC, of Farmington, Pennsylvania, Demco, Inc., of Madison, Wisconsin, Helen Gilmore, Inc., of West Palm Beach, Florida, Michael Olaf Company, of Arcata, California, MPI, of Lansing, Michigan, School Stuff, of Fort Myers, Florida, Sport Supply Group, Inc., of Maple Glen, Pennsylvania, TFH (USA) LTD., of Gibsonia, Pennsylvania, and Vernon Library Supplies, Inc., of Norcross, Georgia. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed discounts, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of May 2002, indicated an increase of 1.2%.
