**SUBJECT: REQUEST FOR AUTHORIZATION TO ENTER INTO PERSONNEL
ASSIGNMENT AGREEMENTS WITH THE DADE PUBLIC EDUCATION
FUND, AND THE UNITED TEACHERS OF DADE/MIAMI-DADE
CHARTER SCHOOLS, INC.**

At the School Board Meeting of June 21, 2000, Agenda Item E-10, the Board authorized a Personnel Assignment Agreement with the Dade Public Education Fund for *FamilyTech*, a program funded by the South Florida Annenberg Challenge. The Dade Public Education Fund is the fiscal agent for the *FamilyTech* program.

The primary goal of *FamilyTech* is to ensure that low income public school students and their families acquire the critical technology literacy skills necessary for success in the 21st century workplace. The *FamilyTech* program is provided to five Miami-Dade County public schools elementary schools (Bel-Aire Elementary, Fienberg/Fisher Elementary, Charles R. Hadley Elementary, Lorah Park Elementary, and Southside Elementary) that have been identified as having large numbers of students receiving free or reduced price lunch.

Authorization of the Board is requested to enter into a Personnel Assignment Agreement with the Dade Public Education Fund to permit Ms. Jennifer Williams to serve as a 10-month Teacher Trainer in the *FamilyTech* program. This agreement will be effective from August 22, 2002 through June 13, 2003. Ms. Williams will be paid through the Division of Instructional Technology and Media Services. The Dade Public Education Fund will provide full reimbursement for Ms. Williams' salary and fringe benefits to Miami-Dade County Public Schools.

On August 22, 2001, Agenda Item E-5, the Board authorized a Personnel Assignment Agreement with the United Teachers of Dade's Charter Schools, Inc., effective from August 23, 2001 through June 10, 2002.

Authorization of the Board is requested to enter into a Personnel Assignment Agreement with the United Teachers of Dade/Miami-Dade Charter Schools, Inc. to permit Mr. Thomas V. Gammon to serve as a 10-month Teacher-Director of the Miami-Dade Charter Schools, Inc.. This agreement will be effective from August 22, 2002 through June 13, 2003. The United Teachers of Dade/Miami-Dade Charter Schools, Inc. will provide full reimbursement for Mr. Gammons' salary and fringe benefits to Miami-Dade County Public Schools. --

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to enter into Personnel Assignment Agreements with the Dade Public Education Fund, and the United Teachers of Dade/Miami-Dade Charter Schools, Inc. to:

1. enable **Ms. Jennifer Williams** to serve as a 10-month teacher trainer in the *FamilyTech* from August 22, 2002 through June 13, 2003 and provide for full reimbursement of salary and fringe benefits to Miami-Dade County Public Schools by the Dade Public Education Fund; and
2. enable **Mr. Thomas V. Gammon** to serve as a 10-month Teacher-Director of the Miami-Dade Charter Schools, Inc. from August 22, 2002 through June 13, 2003 and provide for full reimbursement of salary and fringe benefits to Miami Dade County Public Schools by the United Teachers of Dade/Miami-Dade Charter Schools, Inc..
