The Project Architect's final construction cost estimate for this project is \$2,534,100. The Base Bid of the low bidder is 38.1% under the estimate.

The Electrical and Mechanical scopes of work have been set aside for an African-American/Women owned and operated business.

Advertised bids received and opened on July 16, 2002 by The School Board of Miami-Dade County, Florida have been tabulated and analyzed as follows:

Description

This project is for the replacement of the existing roof system with a SBS modified roofing system at Madison Middle School.

Deductive Alternates

Alternate No. 1 - Delete removal of various roof-top condensing units and associated supports.

Alternate No. 2 - Use of hot-applied roofing system as opposed to cold-applied.

This project is scheduled for substantial completion within 300 calendar days of the contract, or on June 17, 2003.

The Project Architect, LIVS Associates, Inc. recommended award of the contract to the low bidder, Weiss & Woolrich Southern Enterprises, Inc.

One hundred forty pre-qualified contractors were notified of this project and nine firms picked up plans and specifications.

The specified trades were limited to an African-American/ Women owned and operated business. The Division of Business Development and Assistance ascertained that the low bidder complied with the M/WBE certification requirements for this trade.

The Principal/Owner of Weiss & Woolrich Southern Enterprises, Inc. is Mr. Henry Gembala.
