**SUBJECT: REQUEST FOR AUTHORIZATION TO ACCEPT A GRANT AWARD
 FROM THE FLORIDA DEPARTMENT OF EDUCATION, FOR
 FUNDING THE FAMILY LITERACY CORRECTIONS INMATE TO
 INMATE PROGRAM, PROJECT CYCLE: SEPTEMBER 30, 2002
 THROUGH JUNE 30, 2003**

COMMITTEE: FEDERAL PROGRAMS AND GRANTS ADMINISTRATION

Authorization is requested for the Superintendent to accept funds, in the amount of \$75,000, from the Florida Department of Education and provide literacy services to incarcerated youth at the Miami-Dade County Department of Corrections. The Inmate-to-Inmate project will provide supplemental materials, equipment, software and other items needed for instructional activities at Turner Guilford Knight and Metro-West correctional facilities by teachers from Miami-Dade County Public Schools.

Official notification of this grant was received in September 20, 2002, which was after the start of the budget period. The budget period for this grant allows for reimbursement of expenditures from July 1, 2002.

No local funds are required.

2. extend this grant award, at no additional cost, for up to one year, as authorized through official notification from the granting agency, if deemed necessary, in order to complete the scope of the project; and
3. direct Financial Affairs to establish appropriations in the amounts approved by the granting agency with such appropriations to be reported periodically to the Board.
