The purpose of this bid, opened on October 3, 2002, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of frozen pizza, pasta and cheese products, for the Food Service Program of the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 171 vendors sent bid forms or card notices of this advertised bid, 15 responded, with 9 bids meeting specifications, 1 non-responsive bid (bidder did not include bid proposal form) and 5 no bids.
