**SUBJECT: EXTEND CONTRACT NO. 063-AA03 - STORAGE AND DELIVERY OF FROZEN PIZZA AND PASTA PRODUCTS**

**COMMITTEE: FINANCIAL AFFAIRS**

The purpose of the bid, opened on November 21, 2000, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of storage and delivery of frozen pizza and pasta products, for the Department of Food and Nutrition Food Service Program. The terms of agreement, as contained in the contract, awarded by the Board on December 13, 2000, and extended on October 24, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardees have agreed to extend for the final one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of September 2002, indicated an increase of 1.5%.
