Bid No. 008-ZZ03 - MILKSHAKES, ICE CREAM, ICE-MILK PRODUCTS AND FRUIT-JUICE BARS, to establish a contract, to purchase at firm unit prices, quantities, as may be required, of milkshakes, ice cream, ice-milk products and fruit-juice bars, for use in the Food Service Program of the Department of Food and Nutrition, during the term of the bid, effective February 13, 2002, through February 12, 2003. This supplemental award is requested due to increased usage. Last contract usage averaged \$62,697.98 per month, while this year's usage has averaged \$79,93.64 per month. The supplemental amount requested, as determined by the Department of Food and Nutrition, is based on an average monthly expenditure, times the fourteen (14) month contract period, minus the original award amount, plus an anticipated ten percent (10%) increase.
