Emerson Elementary - A0809A

This project is for the removal and replacement of the existing roof system.

This project is scheduled for substantial completion within 210 calendar days of the award date.

One hundred sixty-four pre-qualified contractors were notified of this project and ten firms picked up plans and specifications.

Bent Tree Elementary - A0809B

This project is for the removal and replacement of the existing roof system.

Alternate

Additive Alternate No. 1- Provide either Fully Adhered Sarnafil 90 mil. Feltback Thermoplastic Sheet Roofing or Fibertite 80 mil. Fleece Back Membrane as the Base Thermoplastic Sheet Roofing.

This project is scheduled for substantial completion within 330 calendar days of the award date.

Banyan Elementary - A0809C

This project is for the removal and replacement of the existing roof system.
