This project is scheduled for substantial completion within 210 calendar days of the award date.

The Project Architect, KVH Architects recommended award of the contract to the low bidder, Weiss & Woolrich Southern Enterprises, Inc.

One hundred sixty-four pre-qualified contractors were notified of this project and thirteen firms picked up plans and specifications.
