SUBJECT: EXTEND CONTRACT NO. 136-ZZ10 – FENCE PARTS (SUPPLY ONLY)

COMMITTEE: BUSINESS AND FINANCIAL SERVICES

The purpose of the bid, opened on March 9, 2000, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of fence parts (supply only), for Maintenance Materials Management stock. The terms of agreement, as contained in the contract, awarded by the Board on May 17, 2000, and extended on March 14, 2001, and May 15, 2002, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its second extension period. The awardee has agreed to extend for the final ninety (90) day extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for this period, at the current prices, to benefit from fixed prices, inasmuch as the Consumer Price Index (CPI), as of February 2003, indicated an increase of 3.0%. Staff is in the process of rebidding.
