**SUBJECT: EXTEND CONTRACT NO. 078-BB10 – TEENAGE PARENT
CHILD-CARE SERVICES FOR CHILDREN WHO MEET
LEGISLATIVE ELIGIBILITY REQUIREMENTS FOR THE 2003-
2004 SCHOOL YEAR**

COMMITTEE: BUSINESS AND FINANCIAL SERVICES

The purpose of the Request For Proposals, opened on March 21, 2002, was to establish a contract, at a firm unit price, to provide quality child-care services, for children of teenage parents who are seeking a high school diploma, for the Office of Adult/Vocational, Alternative and Dropout Prevention Programs. The terms of agreement, as contained in the contract, awarded by the Board on June 19, 2002, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardee has agreed to extend for the first one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of February 2003, indicated an increase of 3.0%.
