**SUBJECT: REQUEST AUTHORIZATION TO ENTER INTO CONTRACTUAL AGREEMENTS FOR ADDITIONAL SUMMER READING SERVICES WITH VARIOUS MUNICIPALITIES**

**COMMITTEE: EDUCATION AND SCHOOL OPERATIONS**

The School Board of Miami-Dade County, Florida, at its Board Meeting of April 21, 2003, approved the implementation of the 2003 Summer Program which will serve approximately 100,000 students facing critical academic needs. In order to further provide a productive and safe summer for students, Miami-Dade County Public Schools (M-DCPS) is requesting authorization to provide funds to interested municipalities to augment their summer program by infusing reading activities. Funds must be used to employ M-DCPS certified teachers and purchase materials that support the reading activities.

Request for proposals were sent to 32 municipalities. Seven of the eight that responded requested funding. Municipalities submitted proposals, which included a description of summer reading services that will be provided to the community. If authorized, contracts between the collaborative partners and M-DCPS will be executed to effectuate reading services effective July 1, 2003 through August 16, 2003. } Revis

Each municipality, based on the number of students being served, will receive an allocation of \$5.00 per student per contact hour for the implementation of reading activities. Funds in an amount not to exceed \$501,375.00 are requested to fund reading services for the following municipalities: } Revis

  - Town of Miami Lakes in an amount not to exceed \$41,250.00; } Added
  - City of Sunny Isles Beach in an amount not to exceed \$7,500.00;
  - and
  - City of West Miami in an amount not to exceed \$12,600.00.
