SUBJECT: CORRECT CONTRACT NO. 028-AA02 – HOLLOW METAL DOORS AND FRAMES

The purpose of the bid, opened on January 9, 2001, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of hollow metal doors and frames, for Maintenance Operations. The extended recommendation, approved at the Board meeting of March 12, 2003, incorrectly reflected an estimated expenditure amount of \$7,204.49, instead of \$32,037.64.
