**SUBJECT: RESCIND CONTRACT NO. 116-AA10 - EDUCATIONAL CONSULTATION SERVICES TO PROVIDE ASSISTANCE IN ADDRESSING CONTENT AND INSTRUCTIONAL STRATEGIES IN LOW-PERFORMING SCHOOLS**

The purpose of the Request For Proposals, awarded by the Board on March 14, 2001, was to establish a contract, to provide assistance in addressing content and instructional strategies, to improve student achievement in low-performing schools, for the Office of Curriculum Support Services. At its meeting of March 12, 2003, the Board extended this contract for the final extension period, effective March 14, 2003, through March 13, 2004.

Subsequent to the Board's action, the Office of Curriculum Support Services notified Procurement Management Services that an error had occurred in recommending the extension of the contract. Inasmuch as funds are not available for these services, due to budgetary constraints, the recommendation reflects an action to rescind the contract extension.
