**SUBJECT: EXTEND CONTRACT NO. 130-BB07 - TRANSMISSIONS,
FACTORY REBUILT**

COMMITTEE: BUSINESS AND FINANCIAL SERVICES

The purpose of the bid, opened on May 28, 2002, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of factory rebuilt transmissions, for the Department of Transportation - Vehicle Maintenance. The terms of agreement, as contained in the contract, awarded by the Board on July 10, 2002, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardee has agreed to extend for the first one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of March 2003, indicated an increase of 3.0%.
