SUBJECT: PARTIAL AWARD BID NO. 088-CC03 – FOOD ITEMS: FROZEN AND REFRIGERATED

COMMITTEE: BUSINESS AND FINANCIAL SERVICES

The purpose of this bid, opened on April 15, 2003, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of frozen and refrigerated food items, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 164 vendors sent bid forms or card notices of this advertised bid, 25 responded, with 24 regular bids and 1 non-responsive bid (bidder failed to sign bidder qualification form).

Of bids submitted, Item 7 - Beef, fine ground, Item 13 - Pizza, 16" round, pepperoni and cheese, Item 16 - Roasted chicken parts, Item 17 - Breaded chicken parts, Item 17C - Breaded chicken parts, using donated commodity products, Item 21 - Fully-cooked breaded chicken tender, Item 21C - Fully-cooked breaded chicken tender, using donated commodity products, Item 41 - Arepas, Item 42 - Beef and cheese soft taco, Item 64 - French toast, Item 69 - Pancakes, frozen, Item 71 - Waffles, Item 75 - Broccoli florets, Item 76 - Broccoli Normandy, Item 77 - Carrots, sliced, Item 78 - Collard greens, Item 79 - Cobbetts/cob corn, and Item 81- Peas, green, did not meet specifications, the recommendation reflects that all bids be rejected for these items to permit rebidding.

Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Identical prices were submitted on Item 20C - Fully-cooked chicken patty/fillet-style, using donated commodity products, Kings Delight, of Gainesville, Georgia, and Zartic, Inc., of Rome, Georgia. The recommendation reflects the award of this tie low bid item to Kings Delight of Gainesville, Georgia, the Minority/Women Business Enterprise vendor, who because of lower prices, receives a larger dollar award for other items, pursuant to Board Rule 6Gx13- 3C-1.061 -- Identical Prices - - Priorities For Award.

Item 66 - Muffins, frozen, blueberry, is being held for evaluation and will be scheduled for recommendation at a later Board meeting.
