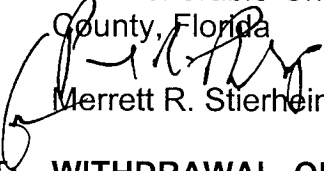

SUBJECT: AUTHORITY TO AMEND THE CAPITAL CONSTRUCTION BUDGET

COMMITTEE: FACILITIES MANAGEMENT

The capital construction budget is being amended to provide additional funding for completion of on-going projects. This item also contains budget changes within programs and between objects.

Staff from the Department of Capital Construction Budgets and Controls has continued to review open purchase orders and fund balances, vis-à-vis the status of projects. Through this process, staff has identified \$8,661,457 that can now be used to fund new projects and to provide additional funding for currently on-going projects that are under funded. To date, staff has identified and reprogrammed \$14,731,026. It is staff's intent to continue this effort and to bring forth additional similar items to the Board in the future.
