Staff has completed the selection process for a Project Architect to provide architectural/engineering (A/E) services for the window replacement and minor updates project at Lenora B. Smith Elementary School. Seven (7) firms applied and the A/E Selection Committee interviewed the following five (5) short listed firms:

Of these five (5) firms, Alleguez Architecture, Inc., was selected for this project. The following A/E Selection committee members were utilized to interview the short listed firms:

Negotiations with Alleguez Architecture, Inc., have been successfully completed. The negotiated basic services fee is \$68,100, with an estimated construction cost of \$830,000. This fee represents 8.20% of the construction cost.

The summary of the basic services is as follows:

• Phase I (Schematics)	\$ 10,600
• Phase II – III (100%)	\$ 32,400
• Bidding/award services	\$ 3,100
• Construction administration services	<u>\$ 22,000</u>
TOTAL FEE	\$ 68,100

Additional fees were also negotiated for the following services:

- At the Board's option, the Project Architect will provide up to 83 site visits at a fee of \$18,500 for the duration of this project (\$200/visit for the architect; \$250/visit for engineers).

Other terms and conditions were negotiated as follows:

- The multiplier for hourly compensation was limited to 2.45 for extra work.
- The Project Architect will maintain a blanket Professional Liability Insurance policy in the amount of, at least, \$1,000,000.
- The Board shall reimburse the Architect for all required contract documents.
- The Project Architect has agreed with the proposed project schedule.

The scope of work for this project includes the following:

- Window replacement at the main facility, Building #1 (which includes classrooms, administration area, dining & cafeteria spaces, and resource rooms).
- Minor updates (which includes minor cabinetry and door replacement in the administration area, replacement of door hardware in building #1 and replacement of stairway handrails to comply with ADA requirements).

RECOMMENDED:

That The School Board of Miami-Dade County, Florida, commission the firm of Alleguez Architecture, Inc., to provide architectural/engineering services for the window replacement and minor updates project at Lenora B. Smith Elementary School, with an estimated construction cost of \$830,000, for the following considerations:

- 1) a basic services fee of \$68,100, which represents 8.20% the construction cost;
- 2) at the Board's option, the firm will provide up to 83 site visits at a fee of \$18,500 for the duration of the project;
- 3) The Board will reimburse the Project Architect for reproduction of all Board required contract documents;
- 4) the multiplier for hourly compensation is limited to 2.45 for extra work; and
- 5) the firm will maintain a blanket Professional Liability Insurance policy in the amount of, at least, \$1,000,000.
