Bid No. 025-AA07 - ORIGINAL EQUIPMENT MANUFACTURER'S (OEM) PARTS FOR SCHOOL-BUS BODIES, to establish a contract, to purchase, at firm discounts, quantities, as may be required, of OEM's parts for school-bus bodies, for the Department of Transportation, Vehicle Maintenance, during the term of the contract, effective January 17, 2003, through January 16, 2004. This supplemental award is requested due to major bus-collision repairs, which have required extensive bus-body parts not previously anticipated. The extension amount for the current contract period was predicated on a usage of \$9,971.38 per month, while the actual usage has averaged \$18,610.08 per month. The supplemental amount requested is based on the average monthly expenditure, times the twelve (12) month contract period, minus the original award amount.
