

**SUBJECT: AWARD BID NO. 007-DD07 – RADIATOR SERVICING AND

The purpose of this bid, opened on August 5, 2003, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of radiator services and repairs, for motor vehicles and equipment, for the Department of Transportation, Vehicle Maintenance. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 104 vendors sent bid forms or card notices of this advertised bid, 3 responded, with 2 bids meeting specifications, and 1 non-responsive bid (Rechtien International qualified bid, not bidding as specified).
