Subsequent to the award, Grizzly General Contractor Corporation, of Medley, Florida, informed the Board of a pricing error, thereby, could not perform in accordance with the terms and conditions of the bid, and has elected by letter, on file, to lose eligibility to transact new business with the Board for a period of fourteen (14) months. Based on the failure of this vendor to perform, it is recommended that the award of this item be terminated, and that Grizzly General Contractor Corporation, of Medley, Florida, lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 -- Performance and Payment Security, Declining A Bid Award, And Bonding Company Qualifications. This item will be purchased, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
