REQUEST AUTHORIZATION TO ACCEPT A GRANT AWARD FROM THE FLORIDA DEPARTMENT OF EDUCATION FOR FUNDING THE ADULTS WITH DISABILITIES AND SENIOR ADULT LEARNERS PROGRAM

EDUCATION AND SCHOOL OPERATIONS

In 1998, the Florida Legislature mandated that a task force be assembled to review current delivery systems for adults with disabilities and to recommend improvements. In 1999, the legislators outlined a process by which funding for such programs would be allocated to the providers. A competitive performance-based grant program was subsequently developed by the Florida Department of Education (FDOE). Only school districts or community colleges were permitted to submit applications. The ranking system for applications required the following:

- 1. cost per individual served;
- 2. potential for improving quality of life through the provision of recreational activities and intellectual stimulation;
- 3. programs that serve adults with disabilities who are not suited for workforce development education programs; and
- 4. programs that provide lifelong learning activities to senior citizens.

No matching funds are required as a condition to receive grant funding. Authorization is requested to accept a grant award from the FDOE to fund the Adults with Disabilities and Senior Adult Learning Program, in the amount of \$2,229,829. This continuation grant will fund the salary of two educational specialists, part-time hourly instructors, training and support services, contracted services, printing, supplies, equipment, software, and travel expenses.

Official notification of this grant award was received on August 19, 2003, which is after the start of the grant period. Reimbursement of grant-related expenditures is authorized effective July 1, 2003.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

- 1. accept a grant award from the Florida Department of Education for funding the Adults with Disabilities and Senior Adult Learners Program in the amount of \$2,229,829 for the grant period of July 1, 2003 through June 30, 2004;
- 2. extend this program as authorized through official notification from the granting agency in order to complete the goals of the program; and
- 3. direct Financial Affairs to establish appropriations in the amounts approved by the granting agency, such appropriations to be reported periodically to the Board.
