Eleven Design/Build contractors responded to the Request for Qualifications and five were selected for invitation to bid on the design criteria. The Independent Cost Estimate is \$9,195,686. The Design Criteria Professional's final construction cost estimate and the construction budget is \$7,538,349. The Base Bid of the low bidder is 9.02% under the budget.

This project includes minority business enterprise subcontracting assistance levels.

Description

This project is for the construction of a new three-story (3), 830 student station building. This addition includes 27 general classrooms, one (1) food management lab, kitchen / dining area and administrative suite.

This project is a design build project. It is scheduled for substantial completion within 578 calendar days from date of award or on May 23, 2005.

The Design Criteria Professional, Spillis Candela, DMJM and staff, recommended award of the contract to the low bidder, Betancourt Castellon Associates, Inc.
