**SUBJECT: AWARD BID NO. 133-CC09M/WBE – CARPET AND FLOOR
TILE, SOUTH OF FLAGLER STREET (FURNISH AND INSTALL)**

The purpose of this bid, opened on July 31, 2003, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, to furnish and install, carpet and floor tile, south of Flagler Street, in schools and facilities of Miami-Dade County Public Schools, for Maintenance Operations. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. This bid is a Minority/Women Business Enterprise set-aside for minority-owned and operated businesses. Of 42 vendors sent bid forms or card notices of this advertised bid, 4 responded, with 3 bids meeting specifications and 1 bid not meeting specifications.
