At the Board meeting of December 12, 2001, the Board authorized the appointment of Dr. Richard H. Hinds, Chief Financial Officer and Mr. Patrick Peters, Finance Coordinator, Office of Risk and Benefits Management, as official representatives of the Board to serve on the Vista Management company 401(k) Advisory Council. Subsequently, at the Board meeting of February 12, 2003, the Board appointed Mr. George M. Burgess to fill the vacancy on the council left by Mr. Peter's resignation. In both of these instances, authorization was received to have the Superintendent sign agreements indemnifying the individuals from personal liability while serving on the Board.

Now that Mr. Burgess has left district service to become County Manager for Miami-Dade County, and Dr. Hinds has retired, its is necessary to have the Board appoint two individuals to serve on the Advisory Council. The recommended replacements are Mr. Edward Marquez, Chief Financial Officer, and Mr. Joseph X. Flynn, Director, Cost and Business Services, Office of Risk and Benefits Management.

A copy of the two agreements requiring the Superintendent's signature, stipulating that Mr. Marquez and Mr. Flynn are members of the Advisory Council, and providing them with the appropriate indemnification are attached.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida:

- appoint Mr. Edward Marquez, Chief Financial Officer, and Mr. Joseph X. Flynn, Director, Cost and Business Services, Office of Risk and Benefits Management, to the open positions as the official representatives of the Board to serve on the Vista Management Company 401(k) Advisory Council; and
- authorize the Superintendent of Schools to execute the attached agreements on behalf of the Board indemnifying Mr. Edward Marquez and Mr. Joseph X. Flynn from personal liability while serving as the Board's duly authorized representatives on the Vista Management Company 401(k) Advisory Council.
