This project has been designated as an open project for all pre-qualified competitive bidders. It also includes minority business subcontracting assistance levels.

The Project Architect's final construction cost estimate for this project is \$5,032,984. The construction budget for this project is \$3,910,000. The Base Bid of the sole bidder is 10.7% over the budget.

Advertised bids were received and opened on June 8, 2004 by The School Board of Miami-Dade County, Florida and were tabulated and analyzed as follows:

Description

This project is for renovating and remodeling of existing building including structural, electrical, mechanical, and plumbing. New classroom construction and an alternate for an airplane hangar.

This project is scheduled for substantial completion within 564 calendar days of the contract, or on January 2, 2006.

The Project Architect, Harper Partners, Inc., recommended award of the contract to the sole bidder, JCI International, Inc.

One hundred fifty-seven pre-qualified contractors were notified of this project and seven firms picked up plans and specifications.

This project was bid with M.B.E. subcontracting assistance levels of 18% African-American and 6% Women. The recommended contractor has submitted the following M/WBE subcontractors as participants in this project for compliance with overall M/WBE assistance levels of 24%.
