The School Board and the Florida Department of Education Office of the Inspector General entered into an Agreement for Intergovernmental Exchange of Public Employees ("Agreement") providing for the Department of Education Inspector General's office to assign an agent to be housed within the Miami-Dade County Public Schools and operate as the Miami-Dade County Public School Inspector General ("M-DCPS-IG"). The effective period of the Agreement is for two years beginning from the hiring date of the M-DCPS-IG, which employment date was June 2, 2003.

At a meeting on May 4, 2005, the School Board confirmed an extension of the Agreement for an additional three months. Thus, the current expiration date of the Agreement is August 31, 2005.

At a meeting on May 14, 2003, the School Board authorized the entering into of an employment contract with Herbert Cousins, Jr., to serve as the M-DCPS-IG. The contract will expire on June 30, 2005. To align the expiration date of the employment contract with the expiration date of the Agreement, authorization is requested to extend the employment contract through August 31, 2005.

Working with the M-DCPS-IG are two Senior Investigators, Frank Angulo, Jr., and George R. Kiszynski, and an Investigative Analyst, Helga R. Gonzalez whose employment contracts would expire on June 30, 2005. To align the expiration dates of their employment contracts with the expiration date of the Agreement and the proposed expiration date of the employment contract of Herbert Cousins, Jr., authorization is requested to extend their employment contracts through August 31, 2005.
