Request For Proposals No. 046-EE10 - COUNSELING SERVICES IN 20 PROGRAMS WITH SELF-CONTAINED CLASSES FOR EMOTIONALLY HANDICAPPED STUDENTS, opened on April 5, 2005, will provide weekly group and/or individual counseling to emotionally handicapped (EH) students assigned to self-contained programs, for the Division of Exceptional Student Education. These services will be provided to students with disabilities, as determined necessary by their Individual Education Plan (IEP). This is a term proposal. Of 37 proposers sent proposal forms or card notices of this advertised proposal, 11 responded, including 1 no proposal. The Board, at its meeting of February 16, 2005, authorized the issuance of the Request For Proposals and approved the appointment of a Selection Committee.

The Selection Committee met to evaluate proposals received in response to the Request For Proposals on April 18, 2005. Ten proposals were presented for consideration: Miami-Dade County Department of Human Services; The Children's Psychiatric Center, Inc.; Bertha Abess Children's Center, Inc.; American Therapeutic Corporation; Stephan G. Chiarini, LMFT; Miami Consultants for Children and Families; PyschSolutions, Inc.; Jewish Community Services of South Florida, Inc.; Eugene E. Muldavin, LCSW; and New Way Day Services. Based on the discussion, the Committee chose to recommend Bertha Abess Children's Center, Inc.; Jewish Community Services of South Florida, Inc.; Miami Consultants for Children and Families; Stephan G. Chiarini, LMFT; Eugene E. Muldavin, LCSW; PsychSolutions, Inc.; and The Children's Psychiatric Center, Inc. for award.
