Request For Proposals No. 045-EE10 - COUNSELING AND PSYCHIATRIC CONSULTATION SERVICES AT ROBERT RENICK EDUCATIONAL CENTER, AND **FOR EMOTIONALLY** CENTER EDUCATIONAL KRUSE **OWENS** RUTH HANDICAPPED AND SEVERELY EMOTIONALLY DISTURBED STUDENTS, opened on April 5, 2005, will provide weekly group and/or individual mental-health counseling and psychiatric consultation to students assigned to the Robert Renick Educational Center, and Ruth Owens Krusé Educational Center, for the Division of Exceptional Student Education. These services will be provided to students with disabilities, as determined necessary by their Individual Education Plan (IEP). This is a term proposal. Of 35 proposers sent proposal forms or card notices of this advertised proposal, 7 responded, including 2 no proposals. The Board, at its meeting of February 16, 2005, authorized the issuance of the Request For Proposals and approved the appointment of a Selection Committee.

The Selection Committee met on April 18, 2005, to evaluate proposals received in response to the Request For Proposals. Five proposals were presented for consideration: Miami-Dade County Department of Human Services; The Children's Psychiatric Center; Bertha Abess Children's Center, Inc.; American Therapeutic Corporation; and New Way Day Services. Based on the discussion, the Committee chose to recommend Bertha Abess Children's Center and The Children's Psychiatric Center for award.
