Request For Proposals No. 068-EE10 - SPEECH AND LANGUAGE PATHOLOGY SERVICES, opened on April 19, 2005, will provide speech and language pathology services for the education of disabled students, whose Individual Education Plan (IEP) indicates the need for such services, for the Division of Exceptional Student Education. This is a term proposal. Of 40 proposers sent proposal forms or card notices of this advertised proposal, 12 responded, including 2 no proposals.

Services may include articulation therapy, language therapy, fluency therapy, and voice therapy in addition to screenings and diagnostics. Students may be in regular programs or in ESE programs (e.g., autistic, learning disabled, physically impaired, educable or trainable mentally handicapped).

The Selection Committee met to evaluate proposals received in response to the Request For Proposals on May 3, 2005. Ten proposals were presented for consideration: Sondra Pierce, d.b.a. ABC Speech and Language Therapy, Bilingual Therapies, Inc.; Bluewater Development, LLC; Cumberland Therapy Services, Inc.; EBS Healthcare, Inc.; Hearing and Speech Center of Florida, Inc.; Invo Healthcare Associates, Inc.; ProCare Therapy, Inc.; Reflectx Staffing and Sunbelt Staffing Solutions. Based on the discussion, the Committee chose to recommend EBS Healthcare, Inc.; Hearing and Speech Center of Florida, Inc.; and Sondra Pierce, d.b.a. ABC Speech and Language Therapy for award.
