**SUBJECT: PARTIAL AWARD BID NO. 082-EE01 – FURNITURE: TABLES,
BOOK DISPLAYERS AND LECTERNS**

The purpose of this bid, opened on April 19, 2005, is to purchase, at firm unit prices, quantities, as may be required, of furniture: tables, book displayers and lecterns, for various locations. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 39 vendors sent bid forms or card notices of this advertised bid, 19 responded, with 15 regular bids and 4 no bids.

Benchmarking was attempted comparing pricing with Palm Beach County, Broward County and Pinellas County School Districts. The pricing received by the District is comparable. In instances where the pricing that is offered to the District is slightly higher, it was determined that the pricing given to Broward County and Pinellas County was offered in 2004. Vendors indicate that pricing to all entities will increase on future bids.

Items 1, 3, 9, 12, 13, 14, 17, 18 and 19 are being held for further evaluation and will be awarded at a future Board meeting.
