The purpose of this bid, opened on April 21, 2005, is to purchase, at firm unit prices, quantities, as may be required, of fruit juices, for the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 40 vendors sent bid forms or card notices of this advertised bid, 4 responded, with 3 bids meeting specifications and 1 no bid.

Inasmuch as the only bid submitted for Item 12 - Apple juice, 4 ounce carton, and Item 16C2 - Apple juice, 6 ounce carton, did not meet specifications, the recommendation reflects that these items be rejected to permit rebidding, using revised specifications.

No bids were received for Item 8 - Juice, 8 ounce, individual plastic bottle. The recommendation reflects that this item be rejected. Competitive prices will be solicited for this item, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Staff completed benchmarking of the items against the contracts for Broward County Public Schools and the School District of Palm Beach County. Results indicated that the District receives better prices, in most cases, than the School District of Palm Beach County. Broward County Public Schools is currently soliciting new prices for these items.
