This project has been designated as an open project for all pre-qualified competitive bidders.

The Project Architect's final construction cost estimate for this project is \$1,853,000. The construction budget for this project is \$1,930,601. The independent cost estimate is \$1,950,564. The Base Bid of the low bidder is 17.4% under the budget.

Advertised bids were received and opened on May 31, 2005 by The School Board of Miami-Dade County, Florida and were tabulated and analyzed as follows:

Description

This project is for a new addition consisting of a two-story Building No. 5 to house toilet rooms, elevator, and two-story covered walkway connection between Building No. 3 and Building No. 4. It also includes renovation of New F/A, P/A, ceiling and lighting, ADA upgrades, window replacement, fire sprinkler, new irrigation and drainage system and the remodeling of Rooms 202 and 204 into new administrative area.

Additive Alternates

Alternate No. 1- Building No. 4 only- Replace 200 window glass panes.

Alternate No. 2- Building No. 4 only- Remove and replace all windows in building, reinstall existing A/C units (Adds 180 days to original contract time).

Alternate No. 3- Building No. 3 only- Remove existing resilient tile, replace (labor only) resilient tile by owner.

This project is scheduled for substantial completion within 575 calendar days of the contract, or on January 11, 2007.

The Project Architect, Architeknics Architects & Planners and staff, recommended award of the contract to Miami Skyline Construction Corp.

One hundred eleven pre-qualified contractors were notified of this project and seven firms picked up plans and specifications.
