The District is currently working with the City of Miami (City) to develop an Interlocal Development Agreement (Interlocal), Lease and Operating Agreement and other related agreements to allow for the construction and operation of a Law Studies, Homeland Security and Forensic Sciences High School, to be co-located with the City of Miami Police Department's proposed new College of Policing facility in downtown Miami. Details of the Interlocal and other agreements are currently under negotiation and it is anticipated that they will be finalized prior to the Facilities and Construction Reform Committee meeting of July 9, 2007.
