SUBJECT: PROVISION OF LEGAL SERVICES

COMMITTEE: INNOVATION, EFFICIENCY AND GOVERNMENTAL RELATIONS

At the School Board meeting of January 17, 2007, the Board Attorney presented her Performance Goals & Initiatives for Calendar Year 2007. As previously advised, one of the School Board Attorney's initiatives was to issue a Request for Information (RFI) in Fiscal Year 2007 for the selection of outside counsel and conflict counsel for the Board for specialized fields of practice. This process was a collaborative effort between the School Board Attorney's Office and the Office of Risk and Benefits Management.

A process for review and evaluation of all proposing firms was conducted by committees consisting of Board Attorneys, Risk Management Staff, and other appropriate District Staff.

RFI numbers 061-GG10 and 081-GG10 were issued to 49 attorneys and firms, as well as a posting on the District's Procurement website. Proposals were opened at the regular bid openings which took place on May 1, 2007 and June 7, 2007.

Proposals submitted pursuant to this RFI establish a list of pre-approved attorneys at the hourly rate specified therein, but do not preclude the Board from retaining other attorneys where the totality of circumstances surrounding the facts so warrant. The District is not obligated to enter into contracts for legal services. Case assignments will be made by the Board Attorney (with input from appropriate District Staff) on an asneeded basis.

The RFI review process has been completed and it is recommended that the following law firms be approved for the provision of legal services. The following list of attorneys and firms represent the highest level of expertise at or below market rate fees. Having these firms under contract will facilitate increased efficiencies in case management.
