The College Assistance Program Inc. (CAP, Inc.) was incorporated in 1978 for the purpose of assisting qualified, economically disadvantaged public high school seniors who demonstrated financial need to attend the college of their choice. Since that time, CAP, Inc. has awarded over \$11 million dollars in "last dollar" grants to more than 100,000 students. One hundred percent of every dollar contributed to CAP, Inc. goes directly to Miami-Dade students, making it possible for their dreams of attending college to become a reality.

College and student advisors provide information and assist students in completing applications for college admission testing, admission to postsecondary institutions, financial aid and scholarships. Advisors also present college workshops to students, parents, and community organizations. Every high school in Miami-Dade County receives CAP services.

This item does not appear in the regularly scheduled agenda. There is good cause to vary from the established agenda because the annual College Assistance Program "Grant Night" will be held on August 7, 2007 and it would be appropriate to adopt this recognition so that it could be received at that event.

Whereas, on August 7, 2007 the College Assistance Program Inc.(CAP Inc.) will celebrate its annual Grant Night and Community Leaders Reception in celebration of the commitment and dedication of CAP and its business and community supporters to the students of Miami-Dade, and

Whereas, the College Assistance Program was founded in 1978 by G. Holmes Braddock, former Miami-Dade school board member, to assist highly qualified, financially needy students to attend college who were otherwise unable to afford the high cost of a college education, and;

Whereas, since its inception the CAP scholarship program has awarded over \$11 million in "last gap" scholarships to academically deserving and financially needy Miami-Dade students who would otherwise not have the means to seek higher learning, and;

Whereas, the CAP program represents a collaboration of the College Assistance Program, the Dade Community Foundation and the Miami-Dade County Public Schools, Division of Student/Career Services, and is governed by a volunteer board of directors which includes prominent business and civic leaders, and;

Whereas, this year's Grant Night will recognize 480 Miami-Dade students as CAP scholars and award them scholarships to schools throughout the State of Florida and beyond.
