SUBJECT: AUTHORIZATION TO ENTER INTO A GRANT OF EASEMENT AGREEMENT WITH FLORIDA POWER AND LIGHT COMPANY FOR THE CONSTRUCTION OF STATE SCHOOL "UU-1" (RELIEF FOR PAUL W. BELL MIDDLE, W.R. THOMAS MIDDLE, AND LAMAR LOUISE CURRY MIDDLE SCHOOLS), LOCATED AT 15015 SW 24 STREET, MIAMI] REVISION

LINK TO STRATEGIC PLAN: IMPROVE CONSTRUCTION SERVICES

In order to meet the electrical service requirements associated with the construction of State School "UU-1", Florida Power & Light Company (FP&L) has requested that an easement be granted. The easement runs along the southern, western and eastern portions of the site, is approximately 10' wide and irregular in shape. The subject area consists of approximately 23,306 square feet; or .535 acres, more or less. The area is legally described in Exhibit "A", attached hereto.

The Grant of Easement Agreement (Agreement) will be reviewed and approved by the School Board Attorney's Office and the Office of Risk and Benefits Management prior to execution. The Regional Center V Superintendent and the Office of School Facilities recommend approval of the Agreement.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorizes the Chair and Secretary to execute a Grant of Easement Agreement with Florida Power and Light Company for the electrical service requirements associated with the construction of State School "UU-1", as described above.

DESCRIPTION FOR FLORIDA POWER & LIGHT. (F.P.L.) EASEMENT

A PORTION OF TRACT "W" SCHOOL SITE OF "GRAND LAKES PHASE III", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 161 AT PAGE 34 OF THE PUBLIC RECORDS OF MIAMI-DADE COUNTY, FLORIDA; BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:



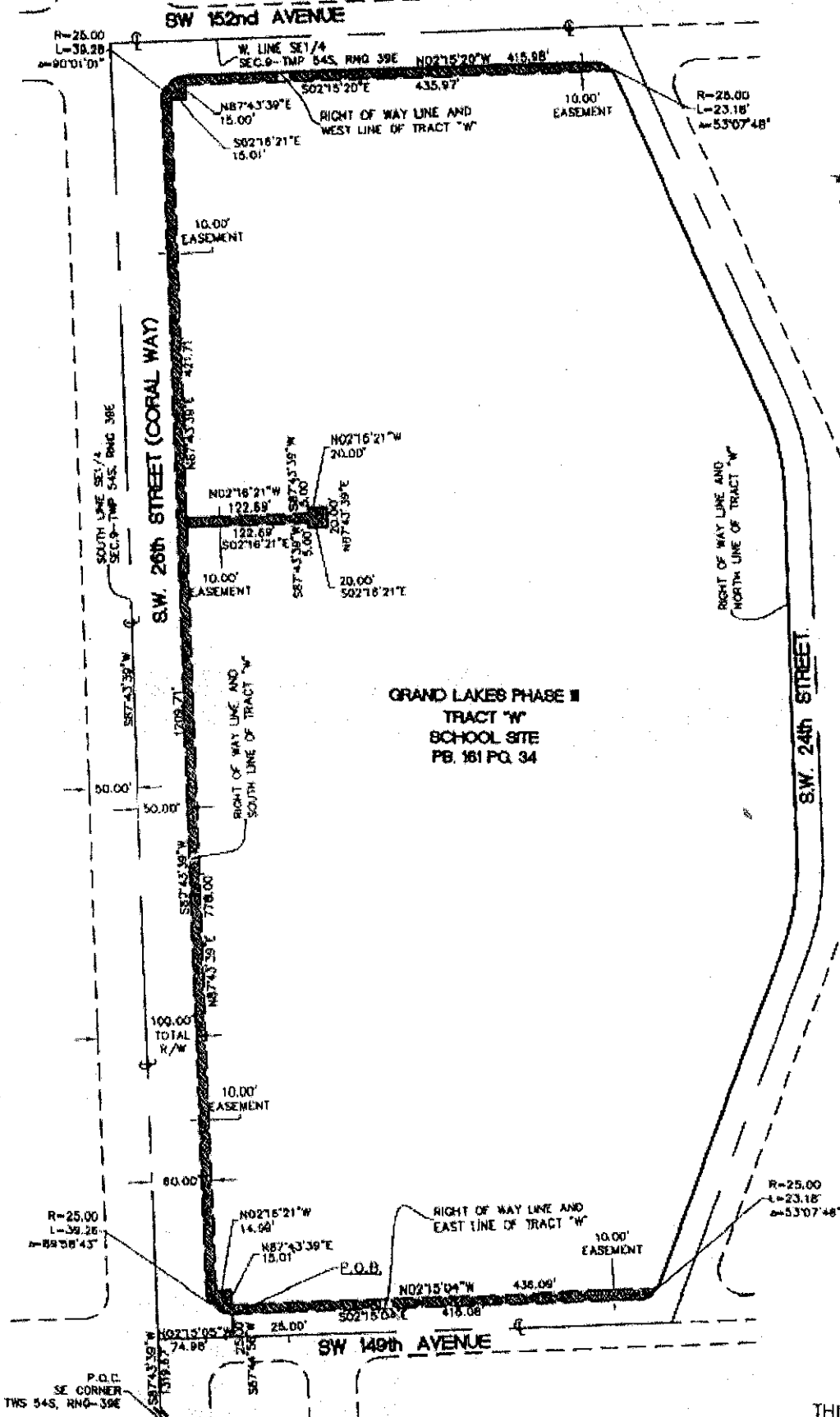
