At its meeting of May 10, 2006 (Item F-25), the Board commissioned Stobs Brothers Construction Company (Stobs) as Construction Management (CM) At-Risk firm for "deferred maintenance package #20, general repairs and rehabilitation" project at Norland Elementary School", Project No. A01098. This contract provides for construction services to the Board and a Guaranteed Maximum Price (GMP) for construction.

The GMP agreed to by Stobs for this project is \$4,999,259 (owner's contingency included \$275,000). The Project Architect's estimate is \$5,246,557 and the independent cost estimate is \$5,512,624. This GMP covers all required work and includes subcontracts, materials, contingency, general conditions, bond, overhead and profit.
