Trees are an important part of the character and landscape of America's parks, forests and plains; they provide many benefits to the environment such as improving air quality, serving as windbreaks and stabilizing soils.

Observances such as Arbor Day help to raise awareness of our environment and the importance of planting trees. The first Arbor Day was organized in the 1800s by Nebraska pioneer and nature enthusiast J. Sterling Morton. A journalist who became the editor of Nebraska's first newspaper, Morton used the print medium to spread agricultural information and his enthusiasm for trees to others who shared his passion for the environment. On January 4, 1872, Morton first proposed a tree-planting holiday at a meeting of the State Board of Agriculture. The date was set for April 10, 1872. More than a century later, Arbor Day is observed across the country and the world by millions of people on the last Friday of April every year. This year National Arbor Day was observed on April 25<sup>th</sup>. P. REVISED
