Section 1002.33(7), Florida Statutes, Charter Schools, requires that the major issues involved in the operation of charter schools be considered in advance and written into a charter school contractual agreement, between the charter school and the sponsor, following a public hearing to ensure community input.

On February 14, 2007, The School Board of Miami-Dade County, Florida, approved a charter school application submitted for Somerset Academy Charter High School (South Campus) and authorized the Superintendent to negotiate a charter school contractual agreement with the applicant for a term of ten years.

South Campus will be located at 23255 SW 115 Avenue, Miami, Florida 33032, and will serve a maximum of 1,000 students in grades nine through twelve commencing with the 2008-2009 school year. However, in its first year of operation, Somerset High South will serve a maximum of 500 students in grades nine and ten. The term of the contract shall be for ten years, ending on June 30, 2018.

The Governing Board of the charter school is comprised of the following members: Mr. Victor Barroso, Account Executive, El Sembrador; Ms. Kim M. Guilarte, Principal, Mater Academy Charter School; Dr. Hui Fang Huang (Angie) Su, Professor, Nova Southeastern University; Ms. Alejandra Salima Jacquinet, Lead Teacher, Mater Academy Charter School; Mr. Carlos Resendez, Fire Retiree Representative, San Antonio Fire and Police Pension Fund; Ms. Cynthia Hanson, Vice President of Marketing & External Relations, Brooks City-Base; Mr. Louis J. Marin, Director of Project Management, San Antonio City Employees Federal Credit Union; and Ms. Meryl Romeu, Parent Representative. This Governing Board currently operates four schools in Miami-Dade.
