Authorization is requested to accept a grant award in the approximate amount of \$1,954,114, from the Florida Department of Education (FLDOE) through the 2008 General Appropriation Act, Specific Appropriation 40, to fund the Adults with Disabilities and Senior Adult Learners Program for the grant period of July 1, 2008, through June 30, 2009. This performance-based grant provides adults with disabilities and adult learners the opportunity for enhancement of skills that are consistent with their abilities and needs. The program provides enrichment activities and classes that address the special educational needs of adult learners by improving their quality of life through the provision of recreational activities and intellectual stimulation. The grant is managed by School Operations and supports the District's mission to provide the highest quality education so that all students are empowered to lead productive and fulfilling lives as lifelong learners and responsible citizens.

The 2007-2008 allocation for this program was \$2,060,427; this year's allocation represents a five percent decrease. No matching funds are required as a condition to receive grant funding. Grant funds cover the salaries of two curriculum support specialists, part-time hourly instructors, professional development and support services, printing, supplies, equipment, software, and travel expenses. Indirect cost is not allowed.

Official notification of this grant award is anticipated on or before September 1, 2008. Reimbursement of grant-related expenditures is authorized effective July 1, 2008.
