**SUBJECT: REQUEST AUTHORIZATION TO ENTER INTO A CONTRACTUAL AGREEMENT WITH BERTHA ABESS CHILDREN'S CENTER, INC., (BACC) FOR THE PERIOD OF AUGUST 5, 2008, THROUGH JUNE 30, 2009, TO PROVIDE SPECIALIZED CLINICAL THERAPY AND PSYCHIATRIC CONSULTATION SERVICES IN A BACC DAY-TREATMENT PROGRAM AT MIAMI PARK ELEMENTARY SCHOOL FOR STUDENTS WITH EMOTIONAL/BEHAVIORAL DISABILITIES WITH INTERNAL FACTORS**

**STRATEGIC PLANS: GENERAL OPERATIONS**

Since 1981, the Bertha Abess Children's Center, Inc., (BACC) has had a cooperative agreement with Miami-Dade County Public Schools (M-DCPS) to provide day-treatment programs for students with emotional/behavioral disabilities (E/BD) at no cost to the District. In light of a reduction in Medicaid revenue that BACC had been receiving for clinical services provided to M-DCPS students, the cooperative agreement, which expired on December 31, 2006, was converted into a contractual agreement through Agenda Item C-22 presented at the School Board meeting held on December 13, 2006. The contract allowed BACC to continue providing services, as designated on student Individual Educational Plans (IEPs), through June 30, 2007. The contract was subsequently renewed at an amount totaling \$600,000, for implementation in six elementary schools during the 2007-2008 school year. In light of the fiscal impact of reductions for the 2008-2009 budget, M-DCPS can no longer maintain the BACC program at six school sites.

Authorization is accordingly requested to enter into a contractual agreement with BACC, in an amount not to exceed \$100,000, to provide a school-based day-treatment program at Miami Park Elementary School for students with emotional/behavioral disabilities with internal factors. Specialized clinical therapy and psychiatric services, as designated on student IEPs, will be offered to students from August 5, 2008, through June 30, 2009.

Through a separate cooperative agreement, BACC will also provide an in-kind, school-based day-treatment program at Palmetto Elementary School at no cost to the District. In addition to these two day-treatment programs that will be administered by BACC in the northern and southern portions of the county, services will also be provided by M-DCPS personnel for E/BD students at the four remaining school sites that had been part of the 2007-2008 BACC contract. In particular, counselors, social workers, trust specialists and school psychologists will apply a consultative team approach to offer counseling services

mandated by student IEPs. The ability to offer these services in-house was also facilitated by the reinstatement of twenty five (25) surplus school psychologists that will participate in specialized professional learning aimed at enhancing their skills in providing E/BD counseling support.

In compliance with student IEPs, BACC will provide clinical individual and group therapy, parent education and family therapy, behavior management programming, crisis intervention services and psychiatric consultation services for E/BD students within the least restrictive environment (LRE). BACC has been recognized by the American Association of Psychiatric Services for Children for its exemplary therapeutic programs. Students that have participated in BACC programs have demonstrated positive academic and behavioral achievements as measured by FCAT developmental scale scores and low suspension rates. BACC programs administered in M-DCPS schools are regularly evaluated by the Division of Special Education through site visits and routine monitoring of student records and program delivery models to insure compliance with requirements set forth in the Individual with Disabilities Education Act (IDEA).

The proposed contract has been reviewed by the Professional Services Contract Committee established by School Board Rule 6Gx13-3F-1.021, during the meeting held on July 17, 2008. The committee has recommended that an exception to the School Board rule regarding bids or Request for Proposals (RFP) be granted in light of BACC's specific expertise in providing specialized psychoeducational day-treatment services.

The appropriation for this item will be included in the Other Federal Programs Fund (Contracted Programs Fund) of the 2008-2009 Tentative Budget to be recommended for adoption in July 2008, under Fund 0420, Function 5200, Program 4501, object 5310, Location 9615. No District general funds will be applied to fund this item.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. grant an exception to School Board Rule 6Gx13- 3F-1.021, based on the provider's specific expertise in offering specialized psychoeducational day-treatment services; and
2. enter into a contractual agreement, in an amount not to exceed \$100,000, with the Bertha Abess Children's Center, Inc., (BACC) for the period of August 5, 2008, through June 30, 2009, to provide specialized clinical therapy and psychiatric consultation services in a BACC day-treatment program at Miami Park Elementary School for students with emotional/behavioral disabilities (E/BD) with internal factors.

The appropriation for this item will be included in the Other Federal Programs Fund (Contracted Programs Fund) of the 2008-2009 Tentative Budget to be recommended for adoption in July 2008.
