Authorization is being requested to approve Resolution 08-86 amending Lease Schedule 2007-1 for Certificates of Participation (COP) Series 2007BC and Lease Schedules 2008B-1 and 2008B-2 for COP Series 2008B. Staff has reviewed all available options to fund capital projects from available funding sources to address the reduction in the 5 Year Work Program due to the August 1, 2008 State Ad Valorem Revenue Estimating Conference. WHEREAS, The School Board of Miami-Dade County, Florida (the "School Board") as the governing body of the School District of Miami-Dade County, Florida (the "District"), has determined to finance certain of its capital needs through a master lease-purchase agreement pursuant to Sections 1001.42 and 1013.15, Florida Statutes; and

WHEREAS, the School Board has the power under Section 1001.42(2), <u>Florida Statutes</u>, to receive, purchase, acquire, lease, sell, hold, transmit and convey title to real and personal property for educational purposes, and under Section 1001.42(9) and 1013.15(2), <u>Florida</u>

Statutes, to enter into leases or lease-purchase arrangements of sites and educational facilities for school purposes; and

WHEREAS, Miami-Dade County School Board Foundation, Inc. (the "Foundation"), a not-for-profit corporation organized and existing under the laws of the State of Florida, has been formed to lease purchase certain real property, educational facilities and equipment to the School Board; and

WHEREAS, the Foundation and the School Board have provided for the lease-purchase financing of certain real property, educational facilities, and equipment (the "Facilities") from time to time by entering into a Master Lease Purchase Agreement dated as of August 1, 1994 (the "Master Lease"), and related agreements; and

WHEREAS, the Facilities leased and to be leased from time to time are identified on separate Schedules (each a "Schedule") attached to the Master Lease; and

WHEREAS, each Schedule, together with the Master Lease, will constitute a Lease Agreement, among which Schedule 2007-1 (the "Series 2007-1 Lease"), dated as of May 1, 2007, as amended and restated as of March 1, 2008, Schedule 2007-2 (the "Series 2007-2 Lease"), dated as of May 1, 2007, as amended and restated as of March 1, 2008, Schedule 2008B-1 (the "Series 2008B-1 Lease"), dated as of May 1, 2008; and Schedule 2008B-2 (the "Series 2008B-2 Lease"), dated as of May 1, 2008, are currently outstanding; and

WHEREAS, the School Board has determined to add Sunset Elementary School -Modular Classroom Addition to the Series 2007-1 Facility Sites and Series 2007-1 Facilities encumbered under the Series 2007 Ground Lease and the Series 2007-1 Lease and reduce project costs for certain Series 2007-1 Facilities as set forth in Schedule 1 attached hereto; and

WHEREAS, the School Board will obtain the consent of Financial Guaranty Insurance Company, as the insurer of the Certificates of Participation, Series 2007B and Series 2007C, respectively, under which the Series 2007-1 Lease has been financed, to the addition of Sunset Elementary School - Modular Classroom Addition to the Series 2007-1 Facility Sites and the Series 2007-1 Facilities encumbered under the Series 2007 Ground Lease and the Series 2007-1 Lease and the reduction of project costs for certain Series 2007-1 Facilities; and

WHEREAS, the School Board has determined to release State School YYY1 (New Senior High School) from and add improvements to High School HHH1 and Miami Senior High_ and construction of new K-8 Center, AA2 to the Series 2008B-1 Facility Sites and Series 2008B- Revised 1 Facilities encumbered under the Series 2008B Ground Lease and the Series 2008B-1 Lease and reduce project costs for certain Series 2008B-1 Facilities as set forth in Schedule 1 attached hereto, and add State School YYY1 (New Senior High School) to the Series 2008B-2 Facilities encumbered under the Series 2008B-2 Lease and reduce project costs for State School YYY1 (New Senior High School) and "Comprehensive Needs" as set forth in Schedule 1 attached hereto; and

WHEREAS, the School Board will obtain the consent of Assured Guaranty Corp. as the insurer of the Certificates of Participation, Series 2008B under which the Series 2008B-1 Lease and the Series 2008B-2 Lease have been financed, to the release of State School YYY1 (New Senior High School), the addition of improvements to High School HHH1 and Miami Senior-High and construction of new K-8 Center, AA2 to the Series 2008B-1 Facility Sites and the Series 2008B-1 Facilities encumbered under the Series 2008B Ground Lease and the Series 2008B-1 Lease, the reduction of project costs for certain Series 2008B-1 Facilities, the addition of State School YYY1 (New Senior High School) to the Series 2008B-2 Facilities encumbered under the Series 2008B-2 Lease and the reduction of project costs for State School YYY1 (New Senior High School) and "Comprehensive Needs"; and

WHEREAS, the School Board has on the date hereof, after due notice as required by law, held an open, public meeting on the proposal of entering into (i) the First Amendment to the Series 2007 Ground Lease for the purpose set forth above (adding Sunset Elementary School - Modular Classroom Addition), and (ii) the First Amendment to the Series 2008B Ground Lease for the purpose set forth above (releasing State School YYY1 (New Senior High School) and adding improvements to High School HHH1 and Miami Senior High and construction of new K-8 Center, AA2, at which meeting a copy of the First Amendment to Series 2007 Ground Lease and a copy of the First Amendment to Series 2008B Ground Lease, in substantially final forms, have been available for inspection and review by the public; and

WHEREAS, there have been presented to this meeting forms of (i) Amended and Restated Schedule 2007-1 to the Master Lease Purchase Agreement, (ii) First Amendment to Series 2007 Ground Lease, (iii) Amended and Restated Schedule 2008B-1 to the Master Lease Purchase Agreement, (iv) First Amendment to Series 2008B Ground Lease, and (v) Amended and Restated Schedule 2008B-2 to the Master Lease Purchase Agreement.

The execution of said Amended and Restated Schedule 2007-1 by the Chair or Vice Chair and the Secretary shall constitute conclusive evidence of the approval thereof. The School Board also authorizes the execution and delivery of a memorandum of lease with respect to the Amended and Restated Schedule 2007-1 and the recording thereof in the Official Public Records of Miami-Dade County.
